
Planning in the Arroyo Colorado Watershed

- 1998 TCEQ began a TMDL study that resulted in the need for a 90% reduction in nutrients
- TCEQ determined that 90% was not attainable
- Watershed Protection Plan was better approach



Arroyo Colorado Watershed Protection Plan (ACWPP)

- Began in 2003 with local interest groups identifying goals to reduce nonpoint source pollution
- Adopted in 2007 by the Partnership
- Ultimate Purpose
 - Create a plan for restoring water quality
 - Educate public on water quality issues





ACWPP Mission

"Reduce the additions of pollutants to the Arroyo Colorado to the maximum extent possible in order to meet state water quality standards and improve the natural terrestrial, riparian, and aquatic habitat associated with the Arroyo Colorado Watershed."

 - Incorporating SWAT results into a hydrodynamic/ Water Quality Model
- Milestones/Accomplishments-1st 10 yrs
- New WWTP's in watershed, MS4
- Increase in population
- Landuse/Urbanization of watershed
 Effects on Ag & Habitat

- SWAT model will locate hotspots-focus BMP's on these areas
- Water conservation
- No Till/Cover Crops and Soil Health
